CEB's Origins and Evolution

It was 1947, and the United States was emerging from the shadow of World War II. After a wartime economic boom, California was adjusting to peacetime population growth – and that included an influx of veterans who sought a speedy return to civilian life.

Some of those veterans were attorneys who resumed practice amid increased demand for legal services across various sectors. And yet, many of them felt underequipped, having discovered that the rules and dynamics of their practices had changed significantly during their time in the war.

What these attorneys needed, UC recognized, was some sort of efficient, accurate, and large-scale program to bring them back up to speed.

The solution became CEB, a self-supporting organization with the goal of assisting WWII veterans in their return to the practice of law. It was a groundbreaking program that pioneered formal continuing legal education in California, hosting live presentations and events throughout the state that were attended by hundreds of attorneys eager to review program materials and talk shop.

The success of those live events led to the development of printed handouts and practice handbooks, which by 1953 evolved into detailed, routinely updated publications for all California attorneys. Tape recordings, video clips, and legal research software followed until we launched our website in 1997, then began releasing online programs in 1999.

Our learning resources now include authoritative research that's both statewide and hyper-local, explainers on key statutory and case law developments, guidebooks, webinars, articles, and more. All of that is backed by leading-edge technology that is constantly evolving to meet user demands.
